INTRODUCTION

The teaching-learning processes were still conducted through online due to the outbreak of Covid-19 pandemic throughout the world, including in Indonesia. Online learning is a distance learning conducted through online. Ermayulis (2021) has defined online learning as learning conducted online using learning applications and even social media. Muhammad (2020) also has stated that online learning is an interactive learning conducted by the teachers

using video conferences. The impacts of Covid-19 have reached the educational domain and online learning has become one solution to overcome the arising problems related to the educational organizations. Hasibun, Simarta, and Hasibuan (2019) have designed online learning as a learning method using the internet-based interactive learning model and Learning Management System (LMS) such as *Zoom, Geogle Meet, Geogle Drive*, etc.

Online activities are not only related to teaching-learning processes, but also other educational activities, such as webinars, workshops, online meetings, final examinations, and more. We are forced to evolve meeting the digitalization era. In facts, not all students could easily access the applications. There were various causes, starting from the limited technological devices and poor knowledge on technology; 4) difficulties in understanding the learning materials since in online classes, are the learning scopes were limited; 5) less effective communication when comparing the online learning with the regular face-to-face learning; and 6) economic difficulties experienced by several students and resulted in poor technological facilities either android, computer, and internet credit quota.

Almost a semester, the researcher has used personal YouTube channel as media to conduct the teaching-learning processes. According to Sianipar (2013), YouTube is data bases containing videos popular in social media and provides various supporting information. The researcher used YouTube as online learning media to create more interesting, fun, and less-boring teaching-learning processes. The learning videos uploaded by the author in the YouTube channels can also be used by the students without any place and time limitation.

The Covid-19 pandemic has greatly impacted on the educational world. However, the educators must strive to find ways to make innovations and self-equip with adequate knowledge beneficial for education. Therefore, the researcher is intended to further discuss the utilization of YouTube as learning media during the outbreak of Covid-19 pandemic. RESEARCH METHOD



This research was conducted starting from November 2020 to March 2021 through the following research stages:




